<b>AGE &amp; WEIGHT CATEGORIES</b>	<p><b>SENIOR:</b> 20 years of age + (born 1998 or earlier)</p> <p><b>Women (WW):</b> 50 kg, 53 kg, 57 kg, 62 kg, 68 kg, 76 kg  <b>Men's Freestyle (FS):</b> 57 kg, 65 kg, 74 kg, 86 kg, 97 kg, 125 kg  <b>Men's Greco-Roman (GR):</b> 60 kg, 67 kg, 77 kg, 87 kg, 97 kg, 130 kg</p> <p>NOTE: Athletes 17-20 years of age (born 1999, 2000, 2001, 2002) may compete, however parental authorization and a medical certificate are required. Athletes 40 years of age and above (born in 1979 or earlier) must provide a medical certificate.</p>



<p><b>ELIGIBILITY REQUIREMENTS</b></p>	<p>Competition is limited to Canadian citizens (athletes). Photo identification must be provided at the time of on-site weigh-ins (any Canadian government issued photo identification will be accepted).</p> <p>All athletes and support staff must be registered members of their PTSO and be members in good standing with their PTSO and WCL as of the time of weigh-in for the event. Please check with your PTSO to determine if they have any additional registration requirements.</p> <p>Officials must be registered members in good standing with CAWO and their Provincial Wrestling Officials Association (if applicable) and WCL.</p>

<p><b>COACHING REQUIREMENTS</b></p>	<p>To receive a coach accreditation (eligible to coach during the event), coaches must have the following MINIMUM elements recorded in their NCCP transcripts, by the registration deadline:</p> <p>1 – Make Ethical Decisions Evaluation 2 – Competition Development CERTIFIED status</p>

Late registrations will be accepted until November 29, 2019 at 11:59 pm ET, but will be subject to a late fee.

**After November 05, 2019 (11:59 pm ET) & prior to November 29, 2019 (11:59 pm ET):**

- Coaches, team managers, team medical \$100
- Training Partners \$15

- All scratches before November 05, 2019 (11:59 pm ET) will be fully refundable.
- All scratches after November 05, 2019 (11:59 pm ET) & prior to November 29, 2019 (11:59 pm ET) will be 50% refundable.
- All scratches after November 29, 2019 (11:59 pm ET) are NON-refundable.
- Injury withdrawals prior to November 29, 2019 (11:59 pm ET) will be fully refundable, upon submission of a physician's note.
