Athletes 40 years of age and above (born in 1979 or earlier) must provide a medical certificate.</p>



<p>ELIGIBILITY REQUIREMENTS</p>	<p>Competition is limited to Canadian citizens (athletes). Photo identification must be provided at the time of on-site weigh-ins (any Canadian government issued photo identification will be accepted).</p> <p>All athletes and support staff must be registered members of their PTSO and be members in good standing with their PTSO and WCL as of the time of weigh-in for the event. Please check with your PTSO to determine if they have any additional registration requirements.</p> <p>Officials must be registered members in good standing with CAWO and their Provincial Wrestling Officials Association (if applicable) and WCL.</p>

Late registrations will be accepted until November 29, 2019 at 11:59 pm ET, but will be subject to a late fee.

After November 05, 2019 (11:59 pm ET) & prior to November 29, 2019 (11:59 pm ET):

- Athletes \$255 (one style – FS or WW or GR);
- Athletes \$300 (two styles – FS & GR);
- Coaches, team managers, team medical \$100
- Training Partners \$15

No registrations will be accepted after November 29, 2019 at 11:59 pm ET. This applies to all athletes, training partners, and support staff.

- All scratches after November 29, 2019 (11:59 pm ET) are NON-refundable.
- Injury withdrawals prior to November 29, 2019 (11:59 pm ET) will be fully refundable, upon submission of a physician's note.
