Considerations / Rationale:

- Participants directly under WCL’s jurisdiction that can be objectively defined and traced

Tier 1 – National / International Participants

- Full-time status ~9-12 month of the year
- Travel to / from the event is considered in WCL’s jurisdiction

Tier 2 – Event-Based National Participants

- Short-term (activities ~2-7 days in length)
- Travel to / from the event is NOT considered in WCL’s jurisdiction

Coaches	<p>Tier 1:</p> <ul style="list-style-type: none">• Any coach receiving a coaching grant (HP & Club Excellence)• Those that have an active UWW licence (from the date of purchase to the end of the calendar year) <p>Tier 2:</p> <ul style="list-style-type: none">• Any individual receiving “Coach” accreditation for a WCL sanctioned event (limited to Canadian Championships & Trials)• Any coach registered to participate in any other WCL sanctioned activity (i.e. training camps, etc.) not specified above

Team Support Staff (Medical & Team Leaders)	<p>Tier 1:</p> <ul style="list-style-type: none"> • Any IST provider receiving OTP directed funding • Those that have an active UWW licence (from the date of purchase to the end of the calendar year) <p>Tier 2:</p> <ul style="list-style-type: none"> • Any individual receiving “medical or team leader” accreditation for a WCL sanctioned event (limited to Canadian Championships & Trials) • Any medical or team leader registered to participate in any other WCL sanctioned activity (i.e. training camps, etc.) not specified above
Officials	<p>Tier 1:</p> <ul style="list-style-type: none"> • Those that have an active UWW licence (from the date of purchase to the end of the calendar year) <p>Tier 2:</p> <ul style="list-style-type: none"> • Any individual receiving “Referee / Official” accreditation for a WCL sanctioned event (limited to Canadian Championships & Trials) • Any referee / official registered to participate in any other WCL sanctioned activity (i.e. training camps, etc.) not specified above

Employees / Contractors	Tier 1
Committee Members + Coach Developers	Tier 1
Event Volunteers	<p>Tier 2:</p> <ul style="list-style-type: none"> • Any individual receiving “HOC and / or event volunteer” accreditation for a WCL sanctioned event (limited to Canadian Championships & Trials)
