**6 STATEMENT OF THE PURPOSE OF THE CORPORATION**

The Corporation has as its exclusive purpose and function the promotion of the sport of Olympic wrestling (referred to as 'wrestling') on a nation-wide basis in Canada. In furtherance of this purpose and function, the purposes of the Association are to:

- serve as the governing body for the sport of wrestling in Canada and, as such, to represent Canada and wrestling to international and national sport governing bodies;
- promote wrestling in Canada, and assist provincial and territorial associations in the development of the sport within their jurisdictions;
- oversee wrestling competitions held under its auspices in Canada;
- establish rules, regulations and standards for the sport of wrestling in Canada;
- host international wrestling competitions;
- identify, select and train members of national teams to represent Canada in international competition;
- receive money and other property, by gift, bequest, fees or otherwise, and to apply same in furtherance of these purpose; and

- carry on related business activities in furtherance of these purposes, such as selling merchandise related to wrestling and to national teams, and engaging in limited non-partisan political activities.”

**8 THE CLASSES, OR REGIONAL OR OTHER GROUPS, OF MEMBERS THAT THE CORPORATION IS AUTHORIZED TO ESTABLISH**

There are two classes of Members:

1. Provincial/Territorial Wrestling Associations
2. Key Stakeholder Groups (Athletes, CIS (Canadian Interuniversity Sport) Coaches, Club Coaches, and Officials)

Each Member carries a single vote, to be exercised by its designated representative at meetings of Members.

Each Member will be entitled to receive notice of, attend and vote at all meetings of Members of the Corporation.

**9 STATEMENT REGARDING THE DISTRIBUTION OF PROPERTY REMAINING ON LIQUIDATION**

Upon the dissolution of the Corporation, any funds or assets remaining after paying all debts and satisfying all liabilities will be distributed to one or more qualified donees within the meaning of the *Income Tax Act*, as determined by the Members prior to dissolution.

**10 ADDITIONAL PROVISIONS, IF ANY**

The directors may appoint one Director, who will hold office for a term expiring not later than the close of the next Annual Meeting of members, provided the one director does not exceed one-third of the number of directors elected at the previous Annual Meeting of members.
