



SAFETY IN SPORT TRAINING, SCREENING & CONSENT REQUIREMENTS

(updated February 25, 2025)

These requirements are applicable to all individuals, in advance of participating in Wrestling Canada Lutte (WCL) sanctioned activities including, but not limited to Canadian Championships and any selection or trials events, training camps, committee meetings, and other as determined by WCL.

***TRAINING:**

Training / evaluation is required to be completed at least once every 4 years, unless otherwise noted. If the certification expires or the training program has been substantially updated to include new important information and resources, individuals will be required to undertake revised training, as directed by WCL.

^SCREENING:

E-PIC – Enhanced Police Information Check (every 3 years)

VSC – Vulnerable Sector Check (once)

When screening a Young Person (younger than 18 years of age), WCL not require a VSC or E-PIC, but will require the individual to submit up to two (2) additional letters of reference.

NOTE: All training, screening & consent must be valid for the duration of the calendar year of participation.
